Annual Report 2021-22









We dream of a world where no child will be deprived of education or be forced to attend a school that will mutilate their spirit.





The almost two-year COVID lock-down was lifted partially at the beginning of the first term of academic year 2021-22 and completely from the second term of the new academic year. The restrictions on children's movements and activities have finally been lifted but not without lasting effects from the forced circumstances. Educational institutions started showing some signs of activity post Diwali. Schools opened but children were still largely missing. The parents were still scared. They would stop sending children to the school at the first mention of a new COVID case in the village or town. Many children had gone to their relatives' places or relocated to their villages and farms during the pandemic and coming back to attend school was not a priority as schools were functioning only at 50 % capacity with alternate day 2–3-hour school. Schools started more or less normally from February 2022.

Many problems surfaced as children started coming regularly to school in June. There were emotional and social problems and educational gaps. The most educationally affected children were in the third, fourth and fifth standards. Teachers too were floundering after two years of unnatural teaching practices. It took time for everybody to get back into the routines of a school-day. The government too started advancing various programs like *Vidya Prawesh* a 6-week program for the first standard children who had missed out on pre-primary school experiences. Then there was *Setu* (bridge courses) with pre- and post-tests, and a remedial program for 5 months from std. 2 to 10. However, whatever remediation is carried out, it will be a couple of years before things go back to normal—or may be a new normal.

Educational Outreach

Bridge Between Pre-primary and Primary: A Continuum in Education

Pragat Shikshan Sanstha (PSS) has been made a partner in the NIPUN Bharat Abhiyan, a government campaign run for achievement of Foundational Literacy and Numeracy (FLN) skills among children in the primary schools. In alignment with the New Education Policy, the campaign expects intervention in the 3–8-year age group. The PSS is permitted to work in Satara and Latur districts under this scheme.

The PSS has started work of intervention in Early Childhood Education (ECE) and lower primary education with a project called 'Bridge Between Pre-primary and Primary: A Continuum in Education' (BBPP) in Ausa block of Latur district and Maan block of Satara district with the funding of H. T. Parekh Foundation. We started work in 25

government primary schools in Ausa and 50 *anganwadis* (AWC) in Maan from October 2021. In both places the nature of work was a direct intervention by a trained team who engaged with children for 2 hours whenever the schools opened. We also carried out baseline and endline assessments on a sample of std. 2 children to gauge the learning loss and to plan the second phase. For the ECE, an added factor was home visits and carrying out activities for children.

In the second phase of the project, that started from April 2022, as regular schools and *anganwadis* started, we started building the capacities of the primary teachers, *anganwadis* workers (AWW) and helpers (AWH) through workshops, on-site support, and exposure visits. We have also added 25 *anganwadis* to the primary schools in Latur. Our direct intervention is in the form of library activities with the children.

We have also given ECE kits, books, and stationery to both *angnwadis* and primary schools. We are also facilitating the use of material provided by the government in the form of language box and mathematics box. We will also carry out a baseline and end-line test for language and math to gauge the effect of our efforts. Liaison with the headmasters, government officials, SMCs and community is an important part of our work. The table below shows the scope and outreach of our program in a nutshell.

In its tradition of developing excellent quality resources, the PSS is now preparing yet another course to help inculcate the love of books among people—especially the children and the teachers with the financial support from Parimal and Pradeep Choudhary Foundation. A panel of resource persons – Sanjeevani Kulkarni, Sushama Sharma, Manjiri Nimbkar, Sujata Lohokare, Vandana Kulkarni, Manasi Mahajan, Faruk Kazi, Meena Nimbkar and Alaknanda Sanap have helped prepare two compendiums after going through a great many articles. Many of these articles came from the compendiums of the Library Educators' Course (LEC) developed by Parag initiative of Tata Trusts. Many others came from Palakneeti archives, TISS Early Literacy resource books and internet. Many had to be translated and resource group also helped in it. The Tata Trusts very kindly paid for the translations.

A pilot is underway at present with a batch of 25 participants. The resource persons are also acting as mentors for the participants. The course will be refined, based on the feedback from the pilot. It will then be opened for anybody who would like to do it for a fee. As the skills the course wishes to develop, are closely associated with the skills of foundational literacy and we feel that many teachers and teacher trainers, both government and non-government, would be interested.

Early childhood education

In the year 2021-22, the balwadis opened only for a month and a half. Only 40-60 % children came regularly. The home visits with learning potli kits to children who did not come continued till March.

In the year 2022-23, the *balwadis* opened on 15th of June. It was almost a month and a half before the children settled down to the classroom routine and could learn. Their self-help skills, self-control and social-emotional skills were found to be severely

affected due to the forced house-bound conditions, lack of peers to play with and lack of routines and systems at home. However, with great efforts in the classroom and continuous communication and counselling with the parents, our team has managed to get a hold on the situation.

Our balwadi team also supports the AWWs and AWHs from Maan and Ausa

blocks as well in the project BBPP. They visit the sites, build capacities of the field team, and offer regular weekly plans for the *anganwadis* to follow. They also prepare videos to guide various activities, respond to questions coming from the field and motivate with an encouraging word on the WhatsApp group.

Apli Shala Library

In the lockdown we started a small library program in Apli Shala* for the children living in Mangalwar Peth, a Dalit area of Phaltan town with the help of the Funds from SPA Foundation. Every day around 20 children of various age-groups came for 2-3 hours in Apli Shala. Today even after the schools have reopened the children come to the library in the evening. Our Balwadi teacher Rajashree Kakade reads with children and conducts various library activities with them.

^{*} PSS runs two balwadis in Phaltan- Kamala Nimbkar Balbhavan (KNB) and Apli Shala (AS), the latter being situated in the underprivileged area of the town. Apli Shala also provides space for the sewing class for women and a library program.

Kamala Nimbkar Balbhavan

The first half of the new academic year continued to be online. The teachers stayed in contact with students and parents mainly though WhatsApp chats, phone calls, videos and Zoom sessions. Parents were called every month to school to give them worksheets and library books for children. Though most of the children were seen to lose interest in this prolonged online mode, many still kept active and sent photos and videos of their work.

In the latter half of the first term the teachers started home visits. Every teacher visited around 8 to 10 homes and spent 1 to 1.5 hours with each child looking at their notebooks, worksheets, teaching a concept, helping them to make daily timetable, giving some routine tasks to them and chatting with parents. The children were delighted, and the parents felt assured. Some children gifted the teachers the handicrafts created by them. Back in the school the teachers wrote reports and shared them with other teachers teaching the same class. This exchange of notes helped the teachers to understand where a particular child stands and how to approach them in online or phone sessions.

It was a great relief to have the students physically present in school from October 2021. The 8th to 10th students came to school from 4 October and the 1st to 7th from 27 November. Taking inspiration from one of the sessions from the eminent educationist Sushil Shukla, we organized a welcome *mela* for the children. After almost 2 years the school seemed full of life as children laughed, chatted, and went around doing

things in the activity corners of their choice. They made garlands of marigold flowers, drew temporary tattoos and mehndi, colored earthen lamps, read books, played games, danced, did origami, science experiments and listened to the stories.


Once the children started coming regularly to school the teachers divided them into small groups and spent time with them to get to understand their academic as well as emotional status. This worked well and children opened up. Every class was given fun periods where they did gardening, clay work, played games, listened to music, and danced. The teachers realized that the learning loss was enormous and designed their teaching accordingly. We have started remedial teaching for the students lagging behind in Marathi, English and mathematics.

Children's Activities

The Annual Project

The theme of this year's project was 'Agriculture'. Students visited farms, poultry, goat farm, plant nurseries, agricultural research institutes, seed and fertilizer shops and the Phaltan sugar factory. These visits were taking place after a long gap and students were very excited. The visits were arranged in small groups of 8-10 sticking to COVID protocol where the parents dropped and picked the children up from the visit sites.

Apart from the visits students did actual farming in the school premises. The first and the second grades set up a small kitchen garden. The seventh students planted onion, fenugreek, beans, brinjal at the back of the school and the eighth students set up a drip system for it. Students also planted sugarcane and maize. They learned the farming processes like weeding, making beds, watering, and harvesting. Sixth grade students prepared a vermicomposting pit.

The third standard students studied different tools used for agricultural work, while the fourth students studied different activities of farming. Class five studied the elements essential for farming, the sixth explored types of agribusinesses while the seventh-grade students delved into the types of agriculture. The eighth studied the importance of crops in Phaltan area especially sugarcane, irrigation systems and importance of soil and climate for agriculture. They also prepared a model of main

crops in Phaltan taluka. The ninth grade tried to understand the farmers' problems. They prepared The Annadata (The food-giver) Rap.

The project exhibition was set up and parents, former students and teachers and students from other schools visited.

Workshops and Talks for Children

Releshani

Releshani (*Shandaar* or splendid relationships) is a three-day workshop conducted by the Arogyabhan Sanstha, Pune for the children in the age group 14-16. It explores the topic of body, mind, health, sexuality, and relationships. Two of these workshops happened for KNB students this year. Students discussed a lot of topics with the Arogyabhan team related to human body, menstrual cycle, and relationships. They sang songs, created live sculptures, and presented plays. On the last day of the workshop students presented what they had learnt in front of their parents. The workshops helped students to open up and become calmer.

Some feedbacks from students after the workshop-

In my opinion the most important topic was about women's periods and male and female reproductive system. Many people follow superstitions. During their periods girls are not allowed to go into the temples. I despise this thought. Releshani team showed us that the process of getting periods is very scientific. In my opinion this process should reach to everyone. I also talked about this process to some women who live near my house, and they replied to me very positively that from now on they will not follow the superstitions. They didn't know about this process, and I helped them to understand it. *Anjali, Grade 9*

I didn't know what an egg or a sperm was. It was important for us to know about it. I think we got to know about it in the right age. *Aditya, grade 8*

I think the most important session was about the growth of a baby in a mother's womb and its birth. I feel good that I know about my mother's menstruation cycle now. I felt very awkward to talk about this topic. Now I feel guite free. *Sanvidhan, grade 8*

I shared the things learnt in the workshop with my Ammi. I had never talked to her this freely. This workshop gave me confidence to talk to her like a friend. The workshop touched almost all the topics, but I feel that it should have covered some issues like sexual abuse, violence, and self-defense. *Jiya, grade 9*

Wildlife Week Lecture Series

On the occasion of the wildlife week which is celebrated from 2nd to 8th October we organized online lectures of some eminent people working in the area of wildlife research and awareness. Dr. Deepak Apte, Marine Ecologist, and former director of Bombay Natural History Society (BNHS) talked about the wonders of underwater marine life. Ornithologist Dr. Girish Jathar took the students in the world of owls while Ms. Priyanka Jundare, Education Officer at BNHS opened the world of butterflies. Naturalist and wildlife photographer Mr. Sunil Karkare enchanted students with his experiences with tigers. After the series we conducted an online guiz for students.

Art Activities

Mumbai based artist and art teacher Shri Ranjit Kokate has been working with KNB students for a year now. He conducted weekly art sessions for students during the lockdown. Now as the school has opened, he visits once in three months and works with children. Mr. Kokate along with our art teacher Ms. Harshada Shinde have been able to make some good changes in children's artistic expressions.

Creating shades

Mr. Kokate conducted an art workshop of 20 students from grades 7 to 10 at a scenic location in Vinchurni. He demonstrated how to make the exact color shade mixing various colors. Students chose various objects from nature and experimented with colors to match their shades.

Indo-Pak Peace Calendar

Aaghaz-e-Dosti, an Indo-Pak friendship initiative launches a calendar every year. The calendar is made from the paintings of school students of India and Pakistan on Indo-Pak peace. 16 KNB students from grades 6 to 10 participated in this year's competition. A 10th standard student Gauri Ghanwat's painting got selected for the final calendar. In her painting there is a white dove (symbol of peace) with the flags of India and Pakistan and hands of different colors are holding each other around it. The caption

of her painting says- Let the hands be held together, Let the peace prevail forever. Gauri was awarded a certificate for this achievement in the online calendar launch held on 23 February 2022.

Hybrid Humans



The students used references of self-portraits and drawings of animals drawn earlier by them and created pictures of hybrid humans. Mr. Kokate emphasizes using of various patterns and textures and this could be seen in these paintings too.

The students joined A4 papers to make bigger paintings and displayed them all over the school in innovative manners.

Wall painting

This project was taken up by the grade 9 students. They first drew big outlines of a tree, a deer, and a crocodile on the white wall of the grade 9 classroom. They generated shadows of different objects like stones, leaves, sticks etc. on the wall with the help of flashlight and drew their outlines. The resultant interesting shapes were then filled with beautiful black and white patterns.



Library Activities

In the lockdown period our librarians Vidyadevi Kakade and Pradip Dhekale routinely sent read-aloud audios and videos to children. The 7th grade students conducted the online reading day for grades 1 to 4. They had arranged quizzes and various games related to story books like riddles, guessing the name of the book from the description, and arranging the events in a story in proper sequence etc. Dhanashri and Ishwari from grade 9 conducted an online interview of Kavita Tiwari, the editor of children's Hindi magazine 'Chakmak'.

Once back in school, students wrote abundantly about their experiences in lockdown. Many of their writings have been published in the school annual 'Navneet'. 18 students' writings and paintings were published in Chakmak this year.

A total of 200 new books were added to the Iravati Karve Library of KNB. The library now has 11600 books. Some were gifted by students and teachers while a few came in Parag Honor List Book Box 2022. It is a curated collection of quality children's literature and KNB library was selected for the book box third year in a row. Dr. Manjiri Nimbkar was invited as a jury member for selecting English books for the PHL Book Box 2022.

Granny Cloud

We have restarted The Granny Cloud program in KNB for grades 4 and 5. Children talk with grannies once a week using Skype. We have got 6 grannies from India, Germany, UK, and Japan.

Grannies tell stories, sing poems and perform puppet shows for students. They also tell the students about their



culture. Sometimes they tell students to find information on the Internet. Students love to talk to the grannies about local festivals, food, and their school experiences. The Granny Cloud program helps in the improvement of students' English comprehension, expression and confidence.

Examinations

Secondary School Certificate (SSC) Exam

For academic year 2021-22 the tenth board exams were conducted in the respective schools in March 2022. Each school was made an exam center for the COVID precautions. The exam result was declared in June 2022. 26 out of 29 KNB students got distinction (marks above 75%). 23 students got marks above 80% and 11 students got marks above 90%. Two girl students got 97.40%, the highest in the school.

Elementary Drawing Grade Exam

Three ninth grade students appeared for the exam and passed with C grade. The exam dates were declared very late, and the students got very little time for preparation.

Teacher Professional Development

Math Workshops

Navnirmiti Learning Foundation, Pune had arranged Curriculum based concept wise online math workshops for classes 1 to 8. Teachers and parents were also encouraged to attend. The focus was on learning concepts by understanding, hands-on problem solving and pattern construction. KNB teachers Mayuri Dhumal and Geeta Bobade attended these classes for two months (twice a week) and learned the effective math pedagogy.

Culture for Inner Growth' (CIG) Intensive

CIG is a program designed by Sahaj Foundation for working professionals and leaders who want to see a positive constructive change in the functioning of their organizations. In this six-week long program the book 'Reinventing Organizations- A Guide to Creating Organizations Inspired by the Next Stage of Human Consciousness' by Frederic Laloux is used as a guide. KNB teacher and education coordinator Madhura Rajvanshi participated in this online course to understand the philosophy and practices for running an organization where people are happier, calmer and more productive. She found this course to be very useful and have started incorporating some practices in the routine work.

Teachers as resource persons

Shikshan Parishad

On the last Saturday of every month an online 'Shikshan Parishad' is organized by the Phaltan Municipality Shikshan Mandal. Teachers from the schools in the city are asked to give presentations on various educational topics. This year three teachers from KNB gave presentations in the Parishad. Vidya Madane presented Kamala Nimbkar Balbhavan's education methods practices COVID lockdown. Mayuri Dhumal gave a presentation about mathematics education and Sanjyot Unde talked about child-centric approach in school education.

Financial Matters

The work of Pragat Shikshan Sanstha has four units based on their goals and funding structure. Apli Shala is the program based in Mangalwar Peth in Phaltan and works with the underprivileged. All the programs of Apli Shala like the balwadis, the library, and sewing class do not charge any fees and are usually funded by outside grants or donations. In the year 2021-22, SPA Education Foundation fully funded the balwadi and the library programs.

Kamala Nimbkar Balbhavan (KNB) is a government recognized unaided Marathi medium school offering an opportunity to learn Math and Science through English from the fifth standard onwards. KNB charges fees and it has a very affordable fee structure. For the academic year 2020-21 KNB charged full fees at Rs. 13,000/- for balwadi, Rs. 13,750/- for grades 1 and 2, Rs. 14,850/- for grades 3 and 4, Rs. 15,400/- for grades 5 to 7, Rs. 15,950/- for grades 8 and 9, and Rs. 17050/- for grade 10. The amount of school fees collected over the year was Rs. 47,17,887/-. However, we have had to waive fees close to Rs. 1,79,605/- as upto 50% concessions were offered to 8 students, while 21 students left school without paying previous fees. These fees had been pending since 2019 when COVID hit the country. In the year 2022-23, the parents were able to pay full fees in 2 or 3 installments.

Twenty-three percent (23%) of the children had 30-60% fee concession depending upon their economic condition. Some institutions and individuals helped 10 students with their fees last year. 25% of children in each class from std. 1 to 7 are given admissions without any fees under the Right to Education (RTE) act. However, the

government reimburses the full fee amount, although not on an annual basis. Last year we received Rs. 50,362/- towards the fees of these children. This fee was part payment from a total of Rs. 10,71,500/- receivable for the year 2018-19. The remaining amount was received in the F.Y. 2020-21. We still have a backlog of three years.

The third unit is the Educational Outreach unit under which we carry out programs with the government schools or community or other educational enterprises. In the previous year, we were carrying out direct intervention in Z.P. schools of Ausa block (Dist. Latur) and *anganwadis* in Maan block (Dist. Satara) through a project called Bridge between 'Pre-Pprimary and Primary schools—a Continuum in Education' supported by funding from H. T. Parekh Foundation. We received a total of Rs. 38,36,000/- from the foundation of which we spent Rs. 37,39,580/- in the previous financial year. Rs. 96,420/- has been carried forward for the next phase of the project as the activities continue. From this project the PSS received an amount of Rs. 3,86,000/- for hosting the project and sharing its premises and resources for the running of the project.

The fourth unit is the Early Childhood Education (ECE) unit conducting six balwadis and carrying out ECE trainings. They have a major contribution to the BBPP-A Continuum I Education project.

The income from donations received, both foreign and domestic, in the year 2021-22 was Rs. 2,27,025/- interest on banks and investments was Rs. 18,97,756/- which is lower by Rs. 70,000/- than the previous year. We received a total of Rs. 1,15,500/- as training fees for on-line trainings conducted for Early Childhood Education, Early Literacy, and library. This has increased by Rs. 33,000/- compared to the previous year.

The royalty on sale of books by Jyotsna publications was Rs. 90,835/- and the amount from sale of books (in-house publications) and other resources was Rs. 11,565/-.

We had a sum of Rs. 18,00,000/- available under the income tax act at the end of the year 20-21 for spending on the objects of the trust over the next 5 years. That was set apart u/s 11(2)(a) of the Income Tax act for carrying out major building and maintenance work, purchase of capital goods and other revenue expenditure on the objects of the trust. Of the above amount, Rs. 7,63,000/- has been spent on building and maintenance activity and revenue expenditure.

We have a Corpus fund of Rs. 1,75,92,287/- to which we have not been able to make any contribution to during the last year.



Fig.1. Enrollment by gender







Fig. 3. Fee Structure





Fig 5. Gender wise enrollment in Balwadis and sewing classes








